Welcome Brethren! President Jim Parker and I were in attendance at the Grand Masters Conference in Baltimore, Maryland. The Conference was from January 15 – 18, 2014. I was unable to stay for the entire Conference but found it to be quite interesting. We had our CD going and the Tri Folds out spreading the word of High Twelve International to those who stopped by to see what we were offering.

There are still a lot of Masons who do not know about High Twelve. We got their information and President Parker will see that they receive information from us. We each attended different breakout sessions where new ideas and suggestions were presented.

International President Parker has decided, that in an effort to have High Twelve International better serve the membership he has divided the States with State Associations and Independent Clubs into zones. Each of the Vice presidents has been assigned a zone of State Associations and/or Clubs that he is responsible for. The Vice presidents will not be making decisions for those Associations or Clubs but will be acting as an interface with them to answer any questions and give them help in resolving any problems that they have or of those that may arise. It is hoped that we will be able to get a better flow of information from and to High Twelve International and the Clubs. We believe that we now have a better understanding of High Twelve Internationals total Membership, but we are not there yet. That is, how many Members are Regular Members and how Members do we have residing at our various Masonic Villages and how many are dual members. This also helps in determining the proper distribution of the High Twelvian Magazine so that we don't have a large number of returned magazines. The Vice Presidents will be looking to the State Associations or Clubs to tell us **what you need from International** but we will also be asking you to supply International with the proper information it needs.

How is this all possible? It takes **everyone's co-operation** for the system to function as a well oiled machine. This is why the President has divided High Twelve International into Zones. We still have some Clubs who are not passing on the proper information to the State Association Secretaries and State Associations Secretaries that are not passing information to High Twelve International. There are those that feel International is not servicing the Associations and Clubs. That is the job assigned to the Zone managers to resolve these issues. **We need everyone to help on this matter.**

The International Secretary has reported that the IRS has received the latest update of the subordinates (Associations & Clubs) included in the International group exemption and they have made the corrections that were listed. Kevin has requested an updated listing to verify that they have truly been made.

We are still working with the Tax Attorney and will keep you informed on this. He is addressing the liability issues if State Associations and Clubs do not file annual tax information returns (990 N E-Postcards).

I hope that everyone has received the news by now that the High Twelve International Secretary, Kevin Hokerk, will soon be supplying the clubs with dues cards for their Members. All the necessary information for the Member will be pre-printed so that all the Secretary needs to do is included the date the card was issued. It will also have the information printed on the side for the records of the Secretary. This will be offered at no cost to the Clubs. However, the member information will come from the Monthly Reports which emphasizes the importance of the State Associations and Clubs sending these reports on a regular basis to us.

Greetings from the West (NO – not the SW).

A couple of nights ago we initiated two EA's and have three more in the queue. Once again I was reminded how fortunate we are to be Masons, and High Twelvians, and decided to drop a few names not to impress but to share a few names from the past.

Names like George Washington, James Monroe, Andrew Jackson, James Polk, James Buchanan, Andrew Johnson, James Garfield, William McKinley, Theodore Roosevelt, Howard Taft, Warren Harding, Franklin Roosevelt, Harry Truman and Gerald Ford. These Brothers certainly had something in common other than being Freemasons! Of these Past Presidents I'm sure you can name the only Past President that was not elected. He was also the only Past President that was a High Twelvian and received the International Founder's Award in 1975 – yep, none other than Brother Gerald Ford from the great State of Michigan.

LBJ received his first degree on October 30, 1937 but after receiving the degree

he found that his congressional duties took so much time he was unable to pursue the masonic degrees.

While Ronald Reagan was not a Freemason he was an honorary member of the Imperial Council of the Shrine and on numerous occasions he was involved in Shrine and Masonic functions throughout this career.

While Abraham Lincoln was not a Freemason he did apply for membership in Tyrian Lodge, Springfield, Ill shortly after his nominations for the presidency in 1860 but withdrew the application because he felt that his applying for membership at that time might be construed as a political ruse to obtain votes. He advised the Lodge that he would resubmit his application again when he returned from the presidency. On his death Tyrian Lodge adopted, on April 17, 1865, a resolution to say "that the decision of President Lincoln to postpone his application for the honours of Freemasonry, lest his motives be misconstrued, is the highest degree honorable to his memory".

Of course all of the above information is online and books but it's always a great reminder of those who have gone before us.

International High Twelve Convention is only 3 months away. As you know, I hope, that the Convention is scheduled at the Masonic Home in Springfield, Ohio. I have visited both Masonic Homes in California and give thanks for these great Masonic benefits - "Masons taking care of Masons". We had a very disappointing turn out at Mid-Year in Vegas last January. Please consider attending the June Convention. It's your organization – join us to plan the "future" of our great organization.

77 clubs have not adopted the Uniform Club Bylaws yet - has your club? All clubs received a hard copy in the mail in August 2013. The document can also be downloaded from the website. You will receive your approved copy back by US Mail promptly!

Customized Dues Cards are now available upon request. Pre-printed is the member name, club number/name, dues period covered and a secretary receipt stub for all members of record.

This office is pleased to continue to supply your new member, guest speaker and presentation certificates along with the other items available on the web site for your club and member needs.

International Website are you using it? If not please do! There is a lot of useful information there!

Events Listing on the website - please provide your association meetings/conventions and club special events so all who visit the site can see what is going on and have the current information and documents to attend.

Wolcott Foundation News:

Following discussions occurring from 1946 to 1950, Dr. J. Wallace Forbes, a professor of Dentistry at Temple University in Philadelphia, Pennsylvania, had submitted a resolution changing the then 'Founders Fund' to 'The Wolcott Fund'.

The Wolcott Foundation Program, as we now know it, came into existence in 1951 as a result of a suggestion by Dr. Forbes, at the High Twelve International Convention in Chicago, to establish an annual scholarship in diplomacy and

statesmanship in one of the few colleges or universities that offered such subjects submitted.

George Washington University entered the picture when Dr. Forbes and his associates were discussing the work being carried out at George Washington University in Government and Foreign Affairs. The sum of \$1,800.00 was appropriated for the tuition for a student at the University to fund one year of graduate studies. The first student selected was Robert Irvine Warriner of Kirkwood, Missouri.

Moving forward to today, your Wolcott Foundation provides the funds to finance the tuition leading to a Masters Degree in the area of Government Service. The description, requirements and application procedure are all contained on the Wolcott Foundation web page – www.wolcottfoundation.com, and you are invited to call up this web page for your examination of its contents. The applicant needs not set pen or pencil to paper - the application can be completed and submitted via computer.

The Wolcott Foundation is composed of ALL HIGH TWELVIANS withersoever dispersed; therefore the Wolcott Foundation is YOUR Foundation, as each Member of High Twelve is a member of the Wolcott Foundation. This is apparently not understood by many, too many, Members. Why so? Because, sad to say, less than one half of the High Twelve Clubs contribute to their Foundation. If it were not for the principle capital endowment, we would not be able to fund as many Fellowships as is now being done. I challenge those Clubs that have not contributed recently to do so now. As one may easily observe, we need to have all of the well educated and highly dedicated workers in government/public service as is possible. Don't be a stranger to 'The Little Red School House.' If your Club does not have such an item, PLEASE contact your Zone Trustee, or me, and that lack can promptly be filled – we have some LRSH's to spare and will get one to you!

Kevin Hokerk, our International Secretary, and I have very recently sent him information on High Twelve and the Wolcott Foundation. I will be doing follow up contact with him.

In the state of Washington, Orville Stoner, Sr, who lives in Bremerton, is very interested in High Twelve and wants to start a club in his area His father, LeRoy Stoner, was a member of High Twelve in Fresno, CA. Kevin mailed a new club kit to Orville and we are looking forward to working with him to open a club in his state.

We have also been contacted by Brother Ethan Wells, who lives in Kentucky. I talked with him on the telephone and mailed him information on High Twelve

Moving to another country, we recently had an inquiry about High Twelve from Brother Micro Ferrari in Italy. He and I exchanged a couple of emails and I learned that he is a member of a Lodge which is under the jurisdiction of the Grand Lodge of Italy. Upon inquiry to Brother Mark Haynes, Grand Secretary of the Grand Lodge of Pennsylvania, it was confirmed that there are two Grand Lodges in Italy, the Grand Lodge of Italy and the Grand Orient of Italy. Brother Haynes informed me that the Grand Lodge of Pennsylvania recognizes the Grand Orient of Italy and that Brother Ferrari's Lodge, Baruch Sjinoza Lodge No. 227, is not listed under the jurisdiction of the Grand Orient of Italy. I communicated this information to him and he was not upset by it. I do, however, want to obtain a better understanding of the recognition process.

Finally, Winton Hewitt, First Vice President, and I have two possible new club opportunities in Pennsylvania. Winton, at a recent Masonic meeting, talked with a Brother from the Pittsburgh area about High Twelve. As a result of the conversation, he had Kevin mail him a new club kit. I have had conversations with a couple of Brothers from the Camp Hill/Mechanicsburg area. A new club kit was sent to the one Brother earlier this year and a presentation to his Blue Lodge was canceled due to the weather. It now needs to be rescheduled for April or May. We never know when these contacts will bear fruit but we need to keep getting the message out there, if we expect to grow High Twelve!

Brother High Twelvians, there are opportunities out there to expand High Twelve. Brother Aretos in Las Vegas said that he just recently learned about High Twelve. Just think about the thousands of Masons who do still not know about it. I want to renew my efforts of contacting those states where we do not have High Twelve Clubs at this time. Once I have completed this project, I am going to recommend to the Executive Committee that we form a committee to strategize how we can best contact Masons in those states where the Grand Lodges are favorable to us. We also need to address those states where we have clubs but were there is still lots of opportunity. In other words, we need a good marketing plan.

Proposed Uniform Association Constitution & Bylaws

The following Uniform Association Constitution & Bylaws were submitted to the Governing Board at the January 2014 Mid-Year meeting and were approved to move forward to the 93rd Annual Convention for consideration:

CONSTITUTION AND BY-LAWS [Insert Name] ASSOCIATION OF [MASONIC] HIGH TWELVE CLUBS [, Inc.]

CONSTITUTION

ARTICLE I - NAME

SECTION 1. The name of this organization shall be "[Insert Name] Association of [Masonic] High Twelve Clubs [, Inc.]

ARTICLE II - OBJECTIVES

SECTION 1. This Association acknowledges the supreme authority of the Grand Lodge(s) of [Enter Grand Lodge Name] in all matters of Masonic law, tradition and ethics. It pledges never to interfere or meddle in the affairs of any Masonic Lodge nor to engage in or sponsor any activity prohibited by said Grand Lodge, nor to permit its members to engage in unseemly, conduct which might reflect adversely upon the institution of Masonry.

ARTICLE III - MEMBERSHIP

Section 1. Members of the Association shall be those High Twelve Clubs that have been chartered by High Twelve International and are under the jurisdiction of the [Enter Association Name] of [Masonic] High Twelve Clubs [, Inc.] Membership in any High Twelve Club in this Association shall be a Master Mason from any jurisdiction that is recognized by the Grand Lodge.

ARTICLE IV - OFFICERS

Section 1. There shall be a President, First Vice President, Second Vice President, Third Vice President (optional), Secretary, and Treasurer. Officers shall be elected and installed at the Annual Meeting of the Association. Upon installation, each officer shall assume the duties of their office for a period of one (1) year or until his successor is duly elected and installed.

Section 2. Eligibility -Any member of a local club holding membership in this State Association shall be eligible to hold office.

ARTICLE V - DUTIES OF OFFICERS

Section 1. The President shall preside at all meetings of the Association and shall be Chairman of the Board of Directors. He shall appoint the standing and other committees as he may deem necessary.

Section 2. The Vice Presidents, in order, shall perform the duties of the President during his absence, inability or vacancy.

Section 3. A vacancy in the office of Secretary or Treasurer shall be filled by appointment by the President. The title of the appointment shall be Acting Secretary or Acting Treasurer.

Section 4. The Secretary shall perform the usual duties of a Secretary at all meetings; and shall provide a permanent written record of the Association's activities. The Secretary shall have possession of all permanent records of the Association.

Section 5. The Treasurer shall receive and disburse the funds of the Association. He shall be a member of the Budget and Finance Committee.

Section 6. The Chaplain shall be appointed by the President. He shall perform the duties usually assigned to the Chaplain and he shall be Chairman of the Necrology Committee.

ARTICLE VI- AMENDMENTS

Section 1. The Association may amend this Constitution by a two-thirds vote at any Annual Meeting, provided that thirty, (30) days written or electronic notice has been provided to each Officer of the Association and to the President and to the Secretary of each Member Club. The notice shall specify in detail all proposed changes to the Constitution. Amendments shall not become a part of this Constitution until approved by High Twelve International.

BY-LAWS

ARTICLE I - MEETINGS

Section 1. The Annual Meeting or Convention of this Association shall be held [between ---- and ---- or on the _____] of each year. At the first meeting of the Board of Directors held following the Annual Meeting the selection of the place and date for holding the next Annual Meeting or Convention shall be determined. The decision of the time and place shall be sent to the Member Clubs.

Section 2. Special meetings of the association may be called by the President. A special meeting requested in writing by three (3) Member Clubs must be held within thirty (30) days of receipt of the request.

Section 3. The Secretary of the Association shall give Thirty, (30) days written or electronic notice of the Annual Meeting, which shall be provided to each Officer of the Association, the President and Secretary of each Member Club and to the Wolcott Zone Officer of High Twelve International.

Section 3. Executive Board quorum shall be a simple majority of the elected association officers.

Section 4. Governing Board quorum shall be a simple majority of the elected association officers and elected Presidents of the Member Clubs of the Association in good standing, or their proxy.

ARTICLE II –NOMINATION COMMITTEE AND ELECTIONS

SECTION 1. The Nominating Committee, appointed by the State President, must be composed of not less than three persons, who shall be active members of a Member Club. The Member Clubs in this Association shall be advised by official publication of the Association or other media of the names of such Nominating Committee members and the name and address of the Committee Chairman. The Nominating Committee shall consist of not more than one individual from any one Club. The Nominating Committee shall present a report at the State Convention of this Association, placing in nomination at least one candidate for each office to be filled by election, and may include the qualifications of each candidate. The acceptance of the Nominating Committee report shall automatically place such names into consideration for election by the delegates in attendance.

At the prerogative of the presiding officer nominations in support of a candidate may be permitted, however; such nominations shall not exceed five (5) minutes in duration. Seconding of nominations will not be permitted.

SECTION 2. Not less than forty-five (45) days prior to the annual State Convention, the Nominating Committee shall submit to the State Secretary the list of nominees for each elective office. The State Secretary shall in turn, notify all members of the State

Governing Board of such nominees. All nominees must be approved and recommended in writing to the State Association within fifteen (15) days of the State Convention by their own Club.

SECTION 3. In addition to the method for nominating candidates to elective office in this Association, nominations may be made from the floor of the annual State Convention providing (1) that the Nominating Committee does not recommend an individual for an office, (2) there is a declared vacancy in that office and (3) such nomination is seconded by a person entitled to vote at the annual State Convention who is not a member of the same Club as the person who made the nomination.

SECTION 4. State Vice Presidents need not be advanced in line. Insofar as possible each State Vice President should be from different geographical areas.

SECTION 5. The candidate for each office receiving the majority of the votes cast shall be declared elected and shall be installed in office at the annual State Convention. A motion to accept each nominee for an office may be made by proclamation at the prerogative of the State President. If an elective officer is absent for legitimate reasons he will be installed with a proxy representing him.

ARTICLE III - BOARD OF DIRECTORS

Section 1. The Board of Directors for this Association shall consist of the President, Vice Presidents, Secretary, Treasurer, Immediate Past President of the State Association, and the President of each Member Club.

Section 2. Each club president or proxy shall be entitled to one (1) vote on matters brought before the Board of Directors.

Section 3. The Board of Directors shall constitute the Administrative body of the Association, and shall transact all business necessary to fulfill the objectives of the Association. At least [three (3)] meetings of the Board shall be held each year.

ARTICLE V – FINANCES

Section 1. The fiscal year for this Association shall be from [Enter start month] through [Enter end month] each year. The Association Budget and Finance Committee, with the input from the State Secretary and State Treasurer, shall submit an annual budget for adoption of the general membership at the annual state convention.

Section 2. The Association shall invoice each Club for their **annual per-capita assessment** (this annual per-capita assessment maybe adjusted from time to time as necessary) of the Association as approved by the Board of Directors at the annual meeting of the Association, on a per member basis in good standing of each Member Club as shown on the [Enter Month] Monthly Report of each Club. Payment of annual per-capita assessment shall be remitted within thirty (30) days after date of the invoice.

- ◇ The Board of Directors shall act on an individual basis on any Club applying for reinstatement or waiver of monies in arrears.
- ◇ Payments for the Association per capita shall be remitted to the State Secretary.
- ◇ The State Secretary shall receive and forward High Twelve International's annual per capita invoice to the State Association clubs for payment. Payments for International per capita shall be remitted as indicated on the invoice.

Section 3. The books and accounts of the Association shall be audited once a year by an

Auditing Committee selected by the President. The report of the Committee shall be read at the first meeting of the Board of Directors following the Annual Meeting.

Section 4. The Treasurer shall disburse such sums for specific purposes as ordered by the Board of Directors or the Executive committee. He shall keep books of account showing receipts and disbursements. Upon receipts of funds he shall deposit them in a federally insured financial institution designated by the Board of Directors. He shall make payments by check or electronic means.

ARTICLE VI – LOCAL REGULATIONS

*(Under this article the Association may provide laws for definitely exclusive local matters not in conflict with the High Twelve International By-Laws, Regulations, Edicts or Decrees. The Association may make as many sections under this article as may be required to meet the needs of the Association. Provisions to be included within this section must be set forth in an Addendum and approved by International Secretary prior to taking effect. **If this article is not used, then it should be left blank and marked NOT USED.**)*

ARTICLE VI - AMENDMENTS

Section 1. The Association may amend these By-Laws by two thirds (2/3) vote at any Annual Meeting, providing that thirty (30) days written or electronic notice been provided to each Officer of the Association and to the President and Secretary of each Member Club. The notice shall specify in detail all proposed changes to the By-Laws. Amendments shall not become a part of these By-Laws until approved by High Twelve International.

Proposed Uniform Club Bylaws Change

The following amendment to the Uniform Club Bylaws was submitted to the Governing Board at the January 2014 Mid-Year meeting and was approved to move forward to the 93rd Annual Convention for consideration:

Submitted by Michael E. Clark PSP, Michigan - January 18, 2014

Current Bylaws—Article III, Section J. Eligibility for Office – Any regular member in good standing shall be eligible for nomination. The President may not succeed himself more than Two (2) successive terms, and no other officer may hold the office for more than three (3) successive terms with the exception of the Secretary and Treasurer.

Proposed Amendment Eligibility for Office – Any regular member in good standing shall be eligible for nomination. There shall be no limitation on successive terms unless the local club shall limit the same.

Reasoning: Many High Twelve Clubs are made up of 10 or fewer members and many of them are for various reasons unable to hold office in their club. Many of these clubs have the same officers for more than two years and some for many years. If this is the wish of the local club, International should not prohibit their determining their own Bylaws. Limiting the number of years officers may serve may have an adverse affect on a club's ability to exist.
