Greetings from the Southwest desert where Spring has been in full bloom!

With the change of me moving from secretary to treasurer at the 98th Convention and the division of responsibilities there are a few things to remember:

- All monetary payments (per-capita, fees, fund raisers, etc.) should continue to be sent me at the new address: **PO Box 1650, Litchfield Park AZ 85340-1650.**
- I will continue to fill all merchandise orders as in the past. Please use the online ordering form and convenient online payment as in the past.
- Annual EIN Validations – thank you to the 85 (62%) EIN Contacts that responded. There are still 52 (38%) EIN Contacts that have not responded. **Please** do it today, it only takes a few minutes to review and update the form, if needed, and return in the self-addressed, postage paid envelope. There is no reason to delay further!
- The group exemption updates were submitted to the IRS on 2/15/2020 as required. There were 59 updates submitted based on the EIN validations received. A later update will be submitted based on any changes from the outstanding 52 EIN Contacts submissions.
- Annual 2020-21 Per-Capita statements will be mailed on 4/30 as per the bylaws. Statements are based on the March 31st Online Monthly Report as stated in the bylaws, not roster numbers. Statements are due and payable upon receipt. The funds should already be in the club treasury to pay the bill. As of 2/3/2020 there are still 5 clubs that are delinquent for 2018-19: #'s 260, 745, 749, 776, 779 – and will be dropped from the rolls automatically at the 99th Convention if not paid. There are also 14 clubs that are past due for 2019-20: #'s 105, 260, 472, 616, 685, 687, 745, 749, 761, 770, 766, 776, 764, 779.

PART TWO: Justification for new Bylaw ARTICLE X

PURPOSE: Establish a new class of membership - Perpetual.

METHOD: Trustees investing funds for income.

FUNDING SOURCE: The Perpetual Life Fund.

Current Article X to be renumbered ARTICLE XII

On the following pages you are seeing the Perpetual Membership proposal that we are going to vote on in June.

The justification for it are as follows:

- High Twelve is one of the few Masonic Bodies without one.
- Some Clubs have an unofficial program right now..
- It will provide Stability for our future, by delaying or eliminating per-capita increases, and as an incentive for younger Brothers to seek membership.
- It will remove some work from the Club, as well as the International Secretaries' desks.
- As a Perpetual member you will be exempt of all dues. Your dues structure will be frozen at the level it was when you qualify.
- You may qualify by paying in a lump sum, or on a monthly basis. For most, the payment would be around \$20-\$25 per month on a regular bank draft until paid out. While you are paying it out, you are still liable for your regular dues.
- Older Members: We all have made a lot of donations to High Twelve over the years, this one has a benefit. While most of us will not outlive the "life" part of our contribution, we will have the satisfaction of knowing that we are helping to make High Twelve available to our children's children, by supplying financial stability. With the benefit of now having our dear Secretary hounding us for our dues money every year.

Proposed HTI By-Laws Amendment #1

ARTICLE X -- PERPETUAL MEMBERSHIP FUND (aka the *Fund and its administration*)

SECTION 1 - PURPOSE

It will provide stability for our future, by delaying or eliminating per-capita increases, and as an incentive for younger Brothers to seek membership.

SECTION 2 - ADMINISTRATION

1. The Fund shall be administered by three trustees (*1 year, 2 year and 3 year initial election, one term expires annually*), elected at the Annual Convention of High Twelve International, who shall serve a term of three (3) years and shall be elected, one each year.
2. No trustee shall serve more than two (2) consecutive full terms.
3. The High Twelve International President, 1st Vice-President, General Counsel, Secretary and Treasurer shall be ex-officio members, without a vote, but in an advisory capacity.
4. There shall be appointed at least three (3) but not more than five (5) members at large from the general membership. Appointed members may serve two terms and still be eligible to be elected a trustee.
5. At the Annual Convention each year the trustees shall determine who shall be Chairman, Secretary and Treasurer.

SECTION 3 - COMPENSATION

As compensation for a full term of outstanding performance, a member of the Fund, may be awarded a Perpetual Life Membership in the President's Club, which, at his election, he may transfer to his home Club by paying the difference in cost for a full Life Membership in his Club.

SECTION 4 - BOARD MEETINGS

1. **Annual Meeting:** The annual meeting of the Fund shall be held at the International Convention each year. This meeting shall also be used to audit the Perpetual Life Membership records of the trustees.
2. **Special Meetings:** Special meetings of the Fund may be called by or at the request of the Chairman or a majority of the members of the Fund stating the purpose/date/time of the meeting, and format (online/telephone/in person).
3. **Notice:** Notice of any annual meeting or special meeting of the Fund shall be given at least seven (10) days written notice sent by mail to each member.
4. **Working Meetings:** shall be announced by email or phone call providing the date/time/purpose and format (online/telephone).
5. **Quorum:** A simple majority of the members of the Fund shall be requisite to constitute a quorum for the transaction of business by the Fund.

SECTION 5: VACANCY

Should a vacancy occur with the elected or appointed member of the Fund, the remaining members shall declare such vacancy after which the International

Officers, shall appoint an eligible High Twelvian to serve until the next Annual Meeting.

SECTION 6: REMOVAL

Any member of the fund may be removed in accordance with ARTICLE II; Section 9 of these by-laws.

SECTION 7: TRUSTEE RESPONSIBILITIES

1. The Chairman shall be the principal executive officer of the Fund and shall, in general, supervise and control directly or indirectly all of the business and affairs of the Fund. He may sign, for the secretary or any other officer of the Fund for bills and notes or other instruments which have authorized to be executed. Any contract(s) must be approved first by the High Twelve International General Counsel.
2. The Secretary shall keep the minutes of all meetings of the Fund, give all notices in accordance with the provisions of these By-laws, and be custodian of the records of the Fund.
3. The Treasurer will be principally responsible to see that appropriate payments are made to the Clubs and Associations, according to their several fiscal years, from Plan investments. Up to 90% of the income derived from those investments be made. He may assign sections of this duty to the other Fund members.

SECTION 8: CHECKS, NOTES, CONTRACTS, ETC.

All Checks, bonds, notes or other obligations for the payment of monies shall be signed by the Chairman or Treasurer and countersigned by the Secretary.

SECTION IX - FISCAL YEAR

1. The fiscal year of the Fund and the anniversary of the election or appointment of each member shall coincide with High Twelve International Convention year.
2. All Monies shall be disbursed by May 31st of each year with a full accounting provided a the Annual High Twelve International Convention.

SECTION X - PERPETUAL MEMBERSHIP

1. A High Twelvian may voluntarily elect to become exempt from paying annual dues to his Club by purchasing a Perpetual Membership; provided he is in good standing in his Club and holds a current dues card. The purchase price for Perpetual Membership is non-refundable, and the funds or revenue derived from their investment are not transferable to any other Masonic or non-Masonic body under any circumstances.
2. An eligible High Twelvian may purchase a Perpetual Membership by remitting a single payment; or if he desires to purchase a Perpetual Membership

- by installment payments, he shall submit a written request or application to High Twelve International, and High Twelve International shall arrange a policy allowing for such installment payments. High Twelve International shall retain the installment payments until the final payment is received from the applicant. A Master Mason making installment payments shall also continue to pay his dues annually until the cost of his Perpetual Membership is paid in full.
3. The single payment purchase price for a Perpetual Membership shall be at least twenty-five (25) year's annual dues, including per capita tax and Association per capita tax, that are in effect at the time of purchase with a minimum of \$300.00. This is further divided into a \$250.00 payment into the Life Fund, and a \$50.00 contribution to the Wolcott Fund. Since a Club may amend its annual dues during any period of installment payments, the installment payment purchase price shall be at least twenty five (25) years annual dues, including per capita, which are in effect on the date of the final payment with a minimum of \$300.00. The \$300.00 minimum means that the applicant must pay the greater of at least twenty (25) years annual dues including per capita tax or \$300.00. The applicant must have remitted to the Club Secretary the amount of existing dues for the following year, which will be retained by the Club. A Perpetual Member shall not be subject to any increases in per capita tax or special assessments by his Club, Association, or High Twelve International. Should High Twelve International raise its per-capita above ten (10) dollars, the minimum fee shall be twenty five (25) times that new per-capita, plus a fifty (50) dollar donation to the Wolcott Fund.
 4. Provided a deceased High Twelvier was in good standing at the time of his death, a Perpetual Membership-Memorial in his memory may be purchased by a Club, another order, by one or more individuals or by any combination thereof. The purchase price shall be a minimum of \$100.00. (Such payment to be retained by High Twelve International, and be equally divided with the Wolcott Foundation)
 5. A Perpetual Member may transfer by affiliating with any Club of his choice within High Twelve International, but if such a transfer requires additional Funds to equal twenty five (25) times the annual dues, including per-capita, of the Club to which he desires to transfer, the required additional Funds shall be remitted with his petition for affiliation. In case of consolidation of a Club, a transfer is not involved, and all Perpetual Members become members of the consolidated Club without any added Funds for Perpetual Members being required-provided that the dues structure of the clubs are within five dollars (\$5.00) of each other. Should the difference be more than five dollars per annum, the affiliating member must either pay 25 times the difference or join the President's Club.

SECTION XI - ADMINISTRATION, INVESTMENTS AND DISTRIBUTION OF EARNINGS

1. Funds received shall be designated as the High Twelve International Perpetual Membership Account and shall not be co-mingled with any High

Twelve Funds, except for investment purposes, but shall be kept apart as a permanent Fund solely for the benefit of the participating Clubs, Associations, and High Twelve International. A separate accounting of the Fund shall be available at the Annual Mid-Year Conference and International Convention.

2. Perpetual Membership. An eligible High Twelvia may purchase a Perpetual Membership by paying the greater of, at least twenty (25) years annual dues, including per capita tax, that are in effect at the time of purchase or a minimum of \$300.00, plus the amount of existing dues for the following year. The Trustees shall annually determine the amount to be distributed based upon the rolling 20 quarter average of the PLM account balance, such amount to be distributed to each Club, Association, and International per-capita. In no case shall the Trustees make any distributions that will deplete assets, nor shall more than ninety (90) percent of income be used for distribution. Ten percent shall be held back each year to hedge against inflation. These amounts shall appear on the Annual Report form sent out by the International Secretary as credits and are to be deducted from the total amount calculated as per capita tax assessments.
3. Should income fall below that needed to Fund a particular year fully, (five (5) percent for the purpose of this document), the income shall be prorated among High Twelve International, State Association (if any) per-capita, and the Local Club. Should a return on investment of more than eight (8) percent be earned on investments, the excess income over eight (8) percent will be equally divided between High Twelve International, Associations, if one exists, the Local Club, and, if living, and he so desires, the Perpetual Life Member.
4. Perpetual Membership-Deceased. Upon the death of a Perpetual Member, his account will be transferred to the Perpetual Membership-Deceased Account. The Fund shall annually determine the amount to be distributed based upon the rolling 20 quarter average of the PLM account balance, such amount to be distributed to High Twelve International, Local Association, if any, and the Local Club, in no case shall the Trustees make any distributions that will deplete assets. These amounts shall appear on the Annual Report form sent out by the International Secretary as credits and are to be deducted from the total calculated as per capita tax assessments portion of the earnings income each year. Investment expenses will be borne from Plan income, and shall be negotiated by the Trustees.
5. A Perpetual Membership member who upon Resignation, Expulsion or Suspension his account will be transferred to the Perpetual Membership-Deceased Account. The Trustees will continue to invest the Funds and only the net earnings derived therefrom shall be available for distribution. The Fund shall annually determine the amount of the earnings to be distributed to each constituent Club, Association, and HTI. These amounts shall appear on the Annual Per-Capita Statement sent out by the HTI Treasurer as credits and are to be deducted from the total calculated as per capita tax assessments. The net earnings credit shall be calculated in the same manner as the regular Fund. If the Brother that formally a member is restored to Active Membership his status will be returned to Regular Perpetual Membership. Should he instead join another club, and there is a difference in the dues structure of more than five dollars per annum, he shall pay 25 times

- the difference in dues to maintain his perpetual membership status.
6. Perpetual Membership Memorial. A deceased High Twelvian in good standing at the time of his death may have a Memorial Membership purchased in his memory by a Club, another order, by one or more individuals, or by any combination thereof for a minimum of \$100.00. Any High Twelvian in good standing with a Perpetual Life Membership may also purchase a Memorial Membership for himself. Memorial Membership shall be considered a contribution, and such contributions will be divided equally between the Perpetual Life Fund corpus, and the Wolcott Foundation to be used at their discretion.
 7. A Club shall deposit all plan income received for Perpetual Memberships into its own bank account and immediately transmit a Club check to the International treasurer. The approved transmittal form shall accompany the payment. Only a fully paid Membership will be handled by the local Club. Incremental payments shall be handled by the Fund trustees.
 8. The Fund trustees shall transmit to the International Secretary the name of each purchasing High Twelvian, the method of payment, the paid in full subscription, and the date received. The International Secretary shall issue a Special Dues card for life members which will be a design distinct from the standard adopted dues card.
 9. The annual dues of each member who purchases a Perpetual Membership shall thereafter be the annual earnings derived from the investment of the purchased Funds, and his Club shall record such earnings as his annual dues for the previous year.
 10. An eligible High Twelvian may purchase a Perpetual Membership at any time, and the Funds remitted are initially invested for a partial year and shall be designated as partial year investments. Earnings on partial year investments shall be calculated for the period corresponding to the High Twelve International fiscal year. Remittances to individual Clubs shall be according to High Twelve International fiscal year. Until the total fee is paid, the Member is still required to pay his Club dues in full.
 11. All High Twelve Perpetual Membership Funds shall be invested in accordance with an investment policy established by a majority decision of the Fund Trustees. No investment company with an employee directly related to a Board member, by blood or marriage may be used. Each trustee must comply with the High Twelve International Conflict of Interest Policy annually at the close of the Annual Convention.
 12. After the close of each plan year, the trustees shall cause an independent audit of the books and records of the Perpetual Account. Constituent Clubs and the trustees shall comply with all applicable requirements and provisions of these By-laws. The trustees shall prescribe the books and records to be kept by the treasurer and shall resolve any inequities or questions not otherwise prescribed by these By-laws, Should a Club or Association become defunct, the Funds received from it and any future earnings shall be held in the investment account until such time that the trustees make a decision on disposition of these monies.

SECTION XII - DUES CARDS

Dues cards for Perpetual Members shall be issued annually by the International Secretary who shall transmit such dues cards to the Club in which each Perpetual Membership is held. On receipt on such dues cards the Club Secretary shall immediately transmit same to each Perpetual Member. The form of the dues card shall be as adopted by the Executive Council, and will be distinct from the regular Dues Card. A permanent dues card may be issued in lieu of a yearly card, if approved by High Twelve International. In either case, the dues card will be distinct from the standard dues card. **END**

Proposed Amendment #2 (If Amendment #1 passes)

Article 1—Membership; Section 2—Local Clubs; Classes

To add a new class of membership:

4. Perpetual Life Member - A member in good standing may choose purchase a Perpetual Life Membership, as described elsewhere in these by-laws, to eliminate the need of paying for dues annually.

Proposed by Mike Haxton, 2nd Vice-President in conjunction with proposed by-laws amendment #1. **END**

Proposed Amendment #3

To follow the current ARTICLE XII (Rev. June 15, 2019 - 98th Convention)

Resolution to Amend By-Laws of High Twelve International Inc.

Where As: The By-Laws of High Twelve International provide provisions for the distribution of funds from the dissolution of High Twelve Clubs and State Associations; and

Where As: There is no provision for the distribution of funds in the event of the dissolution of High Twelve International; and

Where As: The Wolcott Foundation Inc. is the official philanthropy of High Twelve International; and

Where As: The Wolcott Foundation Inc. would continue after the dissolution of High Twelve International; and

Therefore Be it Resolved: In the event of the dissolution of High Twelve International, the President, Secretary or designated officer shall deliver upon the final payment of all debts and obligations of High Twelve International, all funds in all accounts of High twelve International to the Chairman or designated officer

This amendment to the By-Laws of High Twelve International shall be made part of Section **XI. And read as follows:** **“Upon the unfortunate dissolution of High Twelve International, all funds and assets remaining after the settlement of all debts be transferred to the official philanthropy, “THE WOLCOTT FOUNDATION INC.” and transferred to, or through the Chairman of record at the time of distribution or his lawful designate at a time convenient to legal representative not to exceed 90 days from date of dissolution.”**

END OF PROPOSED AMENDMENTS

- New club chartering

HTI Treasurer duties include but not limited to:
