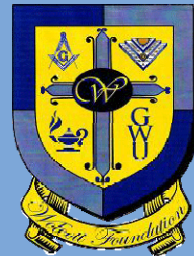

The members of the club could not express enough how impressed they were with Sarah! They wish her well in her future endeavors.

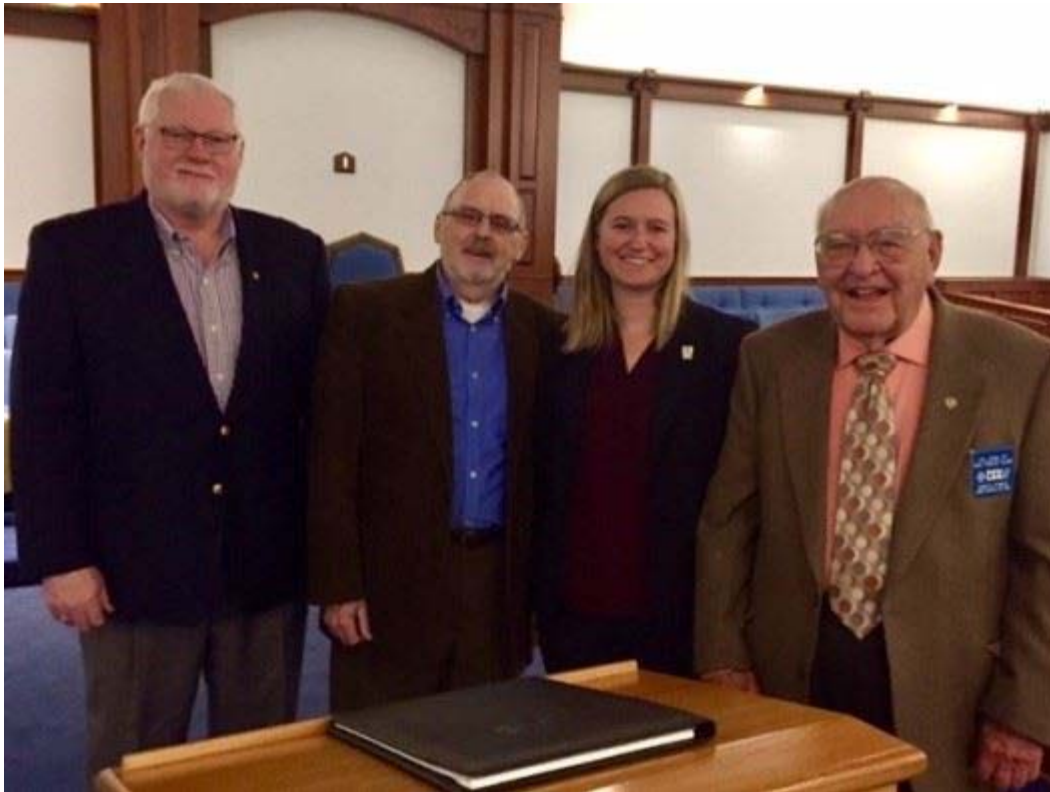
